FROM METROPOLITAN NATIONAL TERRITORY OR GREEN LIST COUNTRIES

SWORN STATEMENT RELATING TO TRAVEL BY AIR OR SEA, FOR ENTRY INTO METROPOLITAN NATIONAL TERRITORY OR FRENCH TERRITORIES .

This statement shall be presented by all travellers coming from the metropolitan national territory or other green list territories, to all transports companies before boarding and to the border control authorities.

These measures apply to vaccinated adult as well as their accompanying minors, vaccinated or not.

These measures are implemented according to the decree n°2021-699 of June 1st 2021, which prescribe the general measures required to the management of the current sanitary crisis, along with the prefectural decree n° 2021-219 CAB/BSI and the 2021-220 CAB/BSI of July 9 2021.

After being duly sworn and according to the law, I declare on my honour that I have not had any of the following symptoms during the last 48 hours :

Fever or chills, Cough or aggravation of my usual cough, Unusual fatigue, Unusual shortness of breath when I speak or make the slightest effort, Unusual muscle aches and/or pains, Unexpected headaches, Loss of taste or smell, Unusual diarrhoea.

I hereby declare on my honour that I have no knowledge of having been in contact with a confirmed case of COVID-19 during the last fourteen days prior to departure.

In the absence of a complete vaccination schedule,* (if I am over 11 years old) I commit to do a prophylactic isolation of 7 days, from the day of my arrival, and I consent to a biological exam, as well as a virological detection, for SARS-CoV-2 after the 7 days of isolation,

** Note : Someone is considered vaccinated if they meet the following criterias : You have a vaccination schedule completed : wich means 2 weeks after injection of the 2° shot of the vaccines that requires it. (Pfizer, Moderna, AstraZeneca)*

4 weeks after the injection of the vaccines that requires 1 shot. (Johnson&Johnson)

2 week after the injection of the unique shot needed, when the subject had contracted Covid-19 prior to it. (Only one injection needed in this case)

Non vaccinated minors can circulate freely, they don't need to present any sworn statement or isolate themselves, if they are with their vaccinated parents.
